
- Agencies will no longer have assigned TABA vendors

  - iCorps team course fees
  - Cybersecurity assistance
- Commercialization peer review
- Agencies must establish a Technology Commercialization Office/Official
  - Provide pathway to Phase III
  - Create Commercialization Impact Assessment
- Now in committee on Small Business and Entrepreneurship

FAST Program extended: Sept 2030

- SBIR allocation increases 4% to 7%
- STTR allocation increases 0.5% to 1%
- Adds Fellowship/Intern opportunities
  - Minority outreach emphasis
- Tech and Business Assistance—TABA
  - Small Business chooses vendor
  - Use funding to hire/train staff
  - Use funding for iCorp training
- Train Federal CO on Phase III funding
- **Establish Technology Commercialization** Office/Officer
  - Produce Commercialization Impact Assessment Report to Congress
- Budget to increase emerging states participation
- Direct to Phase II awards < 10% total

## "Emerging States"

S. 853 Definition

Per S.853: The term 'emerging State' means the 25 States with the fewest combined number of award recipients in the SBIR program and the STTR program that have received their first Phase I award in the previous 10 fiscal years

## **Small Business Act**

Potential amendments per INNOVATE Act

181 SMALL BUSINESS ACT Sec. 9

any other country determined to be a country of concern by the Secretary of State:

(18) the term "malign foreign talent recruitment program" has the meaning given such term in section 10638 of the Research and Development, Competition, and Innovation Act (division B of Public Law 117-167); and

[19] the term "federally funded award" means a Phase I, Phase II (including a Phase II award under subsection (cc)), or Phase III SBIR or STTR award made using a funding agreement.

[20] the term 'emerging State' means the 25 States with the fewest combined number of award recipients in the SBIR program and the STTR program that have received their first Phase I award in the previous 10 fiscal years.

[21] the term 'rural area' means a county or other political subdivision of a State that the Bureau of the Census has defined as mostly rural or completely rural in the most recent decennial census:

(22) the term 'open topic announcement' means a solicitation or SBIR or STTR proposals that—

(A) is a generalized problem statement or broad technology area and does not contain any language requiring that the solutions that a small business concern proposes adhere to specific technological specifications; and

(B) evaluates the ability of the solution proposed by the small business concern to meet the stated innovation need of the agency or Government end user; and

[23] the term 'foreign risk' means, in the past 10 years, any foreign affiliation, technology licensing agreement, joint venture, contractual or financial obligation (pending or otherwise), investment agreement, research relationship (including coauthorship), or business relationship between—

(A) a small business concern (including all subsidiaries, spinouts, and affiliates) submitting a proposal for an SBIR or STTR program, and covered individuals, owners, or other key personnel of the small business concern; and

(B) an individual, research institution, business entity, government, or government—owned entity in a foreign country of concern that is disclosed, as required under subsection (g) or subsection (o), or otherwise identified in the due diligence process, as required under subsection (vv).

(2 <del>(19)</del>

(f) FEDERAL AGENCY EXPENDITURES FOR THE SBIR PROGRAM.—
(1) REQUIRED EXPENDITURE AMOUNTS.—Except as provided in paragraph (2)(B), each Federal agency which has an extramural budget for research or research and development in excess of \$100,000,000 for fiscal year 1992, or any fiscal year thereafter, shall expend with small business concerns—

 (A) not less than 1.5 percent of such budget in each of fiscal years 1993 and 1994;

(B) not less than 2.0 percent of such budget in each of fiscal years 1995 and 1996;

(C) not less than 2.5 percent of such budget in each of fiscal years 1997 through 2011:

(D) not less than 2.6 percent of such budget in fiscal

As Amended Through P.L. 118-159, Enacted December 23, 2024

- TechOpp took S.853 and incorporated the proposed changes into the Small Business Act

Page	Summary	Small Business Concern and/or Action
175	Removed funding <u>reporting</u> on women, socially or economically disadvantaged. Added who reside in emerging states or rural areas.	Small Business in an emerging state is the focus of program reporting. Should encourage Phase-0 state funding.  There was no benefit for disadvantaged small business in the 2022 Extension Act
179	Added Phase 1A for open topics only	Opportunity for small businesses who have no SBIR/STTR awards to enter the program with less of an investment
181	Allocates 10% more workshare to SB and 10% less workshare to RI for STTR only	Increases workshare for small business
181	Added definitions for new terminology such as "emerging states" and "rural areas"	See slide on emerging states and rural areas

- Do you agree with each provision? Or not? And why?
  - Contact your elected official and the Bill's sponsor
  - Do your homework—make your case—offer succinct wording
    - Consider how each element impacts the small business community
- Prepare contingency plan should INNOVATE Act become law
  - If you are a small business who has reached the lifetime limit
    - Begin sourcing other federal funds to replace lost SBIR/STTR funds
  - Never bid an SBIR/STTR? Study the Phase 1A provision
    - Prepare to submit on the next open topic
    - Do your research now to validate an "agency/public need"


