Background



What is the SBIR/STTR program?

Federal Grant Funding sbir.gov/funding

- You have an idea how do you finance it?
- You're likely here (sbir.gov) because you are working on a particular technology or have a specific idea and are looking for funding to advance it.
- Two key steps to find funding through the SBIR/STTR programs:
 - Identify a participating agency or agencies interested in your topic area.
 - Apply to a specific solicitation.



Small Business Innovation Research (SBIR)

→ 3.2% of the extramural research budget for agencies with a budget greater than \$100 M per year

~\$3.2 billion minimum spend each year

Small Business Technology Transfer (STTR)

→ 0.45% of the extramural research budget for agencies with a budget greater than \$1B per year

~\$450 million minimum spould be next!

Over 5,000 new awards every year



SBIR/STTR

Understand and be competitive

Overview

- Meet R&D needs of sponsoring program
- Commercialization of new technology
- Generate new technologies
- Encourages under-represented groups
- Encourages technology transfer

Advantages


- Non-dilutive
- Funding does not require equity stake
- Company owns the IP (Mostly)
- Non-competed follow-on funding
- Defined process and R&D goals

RAMP Act

119TH CONGRESS 1ST SESSION H.R.3239

To improve commercialization activities in the SBIR and STTR programs, and for other purposes.

IN THE HOUSE OF REPRESENTATIVES

May 7, 2025

Small Business Impact



Phase 1A

Not previously received an SBIR or STTR award

- Phase 1A with same purpose as existing Phase I
 - Determine scientific and technical merit and feasibility of ideas that appear to have commercial potential
- Intended to increase accessibility ... for new entrants
 - First time awardees... you could have submitted in the past without success
 - You just must have never received an award
- Proposals submitted ... to only SBIR open topic announcements



Phase 1A Benefits

For first time SBIR awardees

- Bring new small business concerns committed to commercialization of critical technologies into the SBIR program
- Not restricted by location of small business or Principal Investigator educational background
- 2.5% of Agency SBIR funds allocated to the Phase 1A program
- Solicitation will be an Open Topic announcement
- Small Business or Principal Investigator eligible for not more than 1 award for not more than \$40,000



Proposal Specifics

Different than existing Phase I proposal

- Proposal: a report of no more than 2 pages in length covering:
 - Identification of problem—agency and commercial customer
 - Description of solution—technical basis and level of maturity
 - Impact of the solution—beneficial impacts
 - Differentiation—state of solution and unique/novel
 - Commercialization Strategy—how to fund and market description
- Benefits of award
 - Eligible for a Phase II
 - Funds used to develop solution for Phase I or Phase II solicitation



What Happens Next

Prepare for potential Phase 1A proposals

- Open topics should be issued for Phase 1A submissions
- This opportunity is only for small business who have never won an SBIR grant
- The proposal is challenging to "answer the mail" in 2 pages
- IDENTIFICATION OF PROBLEM
 - "The small business concern shall describe the problem that the proposal is intended to address for the awarding agency and any commercial customer"
 - You MUST have 1:1 discussions to learn of the Use Case(s)
 - This is an open topic, so specificity is yet to be determined



Phase 1A more details

Bid/No-Bid Decision

- You get "one shot" per round
- DoD has 15 rounds, other Agencies have one or two rounds
- If you bid and lose, you can bid again (it is assumed)
- If you bid and win, you are ineligible for another Phase 1A
- Should you bid a 1A Open Topic concurrent with Phase I topic?
 - It is not clear what happens if you win the Phase I
- Your goal "today" is to connect with an Operational Unit or an Institutional Department to learn of their problems

Top Level Considerations



SBIR "Tax" Increase

Taken from Agency RDT&E Budget

- Each Federal agency which has an extra- mural budget for research or research and development in excess of \$100,000,000
- Will allocate not less than 3.45 percent of such budget fiscal year 2026 and every Opportunity year thereafter
 - This is increased from 3.2%
 - More funding for small business
- Federal agency ... shall implement a multi-level review and approval process within the Federal agency for solicitation topics to ensure adequate competition
- And that no private individual or entity is shaping the requirements for eligibility for the solicitation topic after the selection of the solicitation topic,
- Except that the Federal agency may amend the requirements to clarify the solicitation topic.



New Restrictions (proposed)



There will be fewer proposing firms

In the proposed legislation: INNOVATE

- "Optimizing SBIR/STTR Funding"
 - A small business concern, including its affiliates, spinouts, or subsidiaries, may not apply to a Phase I or Phase II solicitation under an SBIR or STTR program if the small business concern, including its affiliates, spinouts, or subsidiaries, has previously received over \$75,000,000 in funding from SBIR or STTP hase I and Phase II awards.
- Immediately eliminates ~ 70 small businesses
 - Another 10 companies are at risk, having \$65M lifetime awards



What is the math?

What does it mean for a Start-Up?

- Total SBIR/STTR awarded amount (since 1983) = \$77,206,393,190.88
- How much of that is awarded to ineligible companies = \$11,966,186,387.98
- Percent of firms (by dollar awards) eliminated = 15%
- Firm count that have won at least one award = 214,282
- By eliminating the top performers in the program, new companies are needed to fill the gap
 - Thus, the language of the bill: "Encouraging new SBIR and STTR Entrants"



These also reduce the "playing field"

- An individual may not concurrently serve as the primary investigator on more than 1 proposal to a single Phase I solicitation or a single Phase II solicitation
 - May severely limit very small businesses to "put all their marbles in one bag" for every solicitation
- A small business concern applying for a Phase I award may not have annual receipts of more than \$40,000,000 for the most recent fiscal year
 - For high-tech NAICS codes, the SBA defines a small business as having up to \$41.5 annual revenue
 - Reasonable to infer that only a small fraction of high-technology small businesses exceed \$40M in annual revenue
 - Possibly minimal impact on SBIR/STTR submissions



These also reduce the "playing field"

- A small business concern, including its affiliates, spinouts, or subsidiaries, may not submit more than 3 proposals to a single Phase I solicitation or a single Phase II solicitation
 - The June 4 DoD solicitation alone has 122 topics
 - What if you have multiple Phase I awards preceding a Phase II?
- A small business concern, including its affiliates, spinouts, or subsidiaries, may not submit more than a combined total of 25 proposals to Phase I solicitations or Phase II solicitations published by a single agency, including the components of the agency, in a single fiscal year.
 - DoD issues topics 15 times a year
 - The DoD SBIR 2024.4 includes 96 active topics—39 are D2P2
 - This severely limits the responses they will receive
 - Opens the field for more small businesses





These also reduce the "playing field"

- The Department of Defense and the National Aeronautics and Space Administration shall use their STTR budget to solely fund research at technology readiness levels 1, 2, and 3
- Each Federal agency shall use its STTR budget to fund small business concerns conducting fundamental, basic, or other scientific research that stands to benefit most from partnerships with eligible research institutions.
- STTR funding is cut in half beginning in 2026
 - From 0.45% to 0.20%
- Allocates 10% more workshare to SB and 10% less workshare to RI



Direct to Phase II awards

- An agency may not make an award under this subsection to a small business concern, including its affiliates, spinouts, and subsidiaries, that has received more than 25 [direct to] Phase II awards
 - Assuming this is lifetime
- An agency may make not more than 25 awards under this subsection to a small business concern, including its affiliates, spinouts, and subsidiaries



Phase I to Phase II conversion

Metrics established

- For small business concerns that received or receive more than 10. Phase I awards, establish a minimum performance standard with respect to the receipt of Phase II awards that shall be a ratio of at least 0.25 for the number of Phase II awards received as compared to the number of Phase I awards received
- With respect to a small business concern that received or receives more than 25 Phase I awards, the minimum performance standard shall be a ratio of at least 0.5 for the number of Phase II awards received as compared to the number of Phase I awards received
- Penalty: May not participate in Phase I for one year and limited to 5 Phase I awards/year until metric is met



Added Benefits

Other than restrictions

- Commercialization Readiness Program is now the "Strategic Breakthrough Awards" program
 - The Secretary of Defense and the Secretary of each military department is authorized to ...
 - Provide funding to accelerate the transition of technologies, products, and services developed under the SBIR or STTR program to Phase III, including the acquisition process
 - Identify research programs of SBIR/STTR program that have the potential for rapid transitioning to Phase III and into the acquisition process
 - The Department of Defense shall establish a mechanism, such as a major system, to provide small business concerns with direct access to program and requirements offices throughout the DoD that may purchase technology from small business concerns under Phase III of the SBIR program of the DoD
- Any funding agreement that is a contract made with expenditures allocated to the SBIR program ... shall be a firm-fixed-price contract, unless, on a case-by-case basis, the head of the awarding Federal agency makes a written determination to utilize a different contract structure.



Commercialization

Revenue metric established

- A small business concern...that has received more than 25 Phase II awards over its lifetime, require the <u>sum of the annual receipts</u> ... from <u>sources other than</u> Phase I or Phase <u>II CDID ar CTTD and the sum of the sources other than</u> Phase I or Phase <u>II CDID ar CTTD and the sources other than</u> Phase I or Phase <u>II CDID ar CTTD and the sources other than</u> the sum of the dollars awarded through Phase I and Phase II awards <u>since the date of the first such award</u>
- A small business concern that receives more than 25 Phase II awards over its lifetime, require a mall business concern that receives more than 25 Phase II awards over its lifetime, require a mall business concern during the Syears preceding the most recent fiscal year come from sources other than Phase I or Phase II SBIR or STTR awards.

- Read the proposed legislation
- Do you agree with each provision? Or not? And why?
 - Contact your elected official and the Bill's sponsor
 - Do your homework—make your case—offer succinct wording
 - Consider how each element impacts the small business community
- Prepare contingency plan should INNOVATE Act become law
 - If you are a small business who has reached the lifetime limit
 - Begin sourcing other federal funds to replace lost SBIR/STTR funds
 - Never bid an SBIR/STTR? Study the Phase 1A provision
 - Prepare to submit on the next open topic
 - Do your research now to validate an "agency/public need"


